ACKNOWLEDGMENT AND AGREEMENT – CHINA ADOPTION

We, ADOPTIVE PARENT NAMES, the undersigned, hereby acknowledge receipt of our picture(s) and medical information on our child, ADOPT CHILD NAME . We understand that we have been provided all the medical information that was provided to Families Thru International Adoption (FTIA) by the Chinese authorities. FTIA has very clearly stated that they do not guarantee the accuracy of any medical information provided by the Chinese authorities. We understand, and with full knowledge that we are not certain of the medical/social/developmental/emotional condition of ADOPT CHILD NAME, by our signatures below, we are agreeing to complete the adoption of ADOPT CHILD NAME through FTIA by traveling to China when permitted by the Chinese authorities. We further agree that upon our decision to accept the referral of ADOPT CHILD NAME to overnight the last part of our FTIA agency fee along with this Acknowledgment and Agreement and the China Center of Adoption Affairs Acceptance Form to Families Thru International Adoption.

We understand that China requires two (2) post-placement reports after our return from China. The first post-placement report is to be submitted no later than six (6) months after our return and the second post-placement report is to be submitted no later than twelve (12) months after our return. These post-placement reports are to be performed by the agency who completed our original home study or another licensed home study agency. By our signature below, we are agreeing to complete the post-placement reports as required by China, although this may present additional cost. We also agree that if China changes their post-placement requirements to require additional post-placements, we will comply with the Chinese regulations even though it will result in additional cost to us.

We agree that we will not hold FTIA legally liable and that we will not pursue any legal action against FTIA in the event there is a medical/social/developmental/emotional condition present which is not indicated on the medical information provided to us, whether detected, observed, and/or diagnosed in China or after our return to the United States after adopting in China. We affirm that we have had the opportunity to ask any questions or request additional information. We understand that if we requested additional information, that if the additional requested information is in fact provided, all information that FTIA receives will be forwarded to us.

We agree to obtain our child's Certificate of Citizenship within one year of our return from completing our adoption in China and to send FTIA a copy of the Certificate of Citizenship when received from the CIS.

We understand and agree to incorporate this Acknowledgement and Agreement with all the terms of the Adoption Services Agreement we signed earlier in this adoption process.
